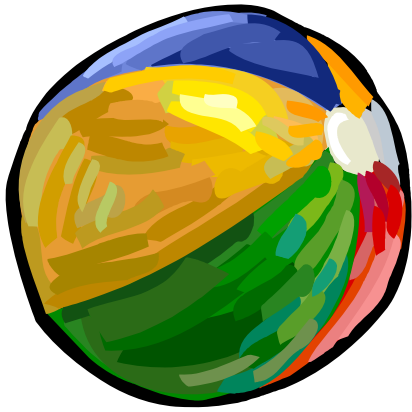
We will be electing two members to the Board at the October meeting. If you are interested in being on the Board please come to the Community meeting on September 11th, or call anyone on the Board to volunteer.

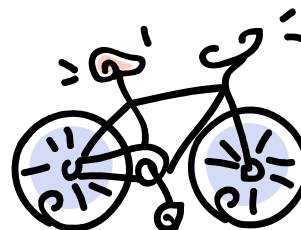

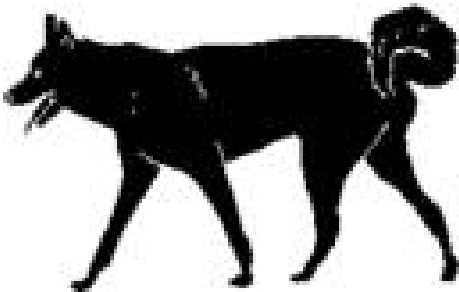
